- Phantom shares held in a multi-fund deferred compensation plan to be settled for cash upon the reporting person's termination of employment for any reason on a 1:1 basis. Shares are acquired through regular periodic contributions, company matching contributions, and the automatic reinvestment of dividends.
- Balance includes 7 shares acquired on 03/10/2006 and 6 shares acquired on 06/10/2006 through the automatic dividend reinvestment feature of Exelon plans.
- Performance Shares awarded pursuant to the Exelon Long Term Incentive Plan. 1/3 of the shares awarded vest immediately upon receipt. The remaining shares vest in 1/3 increments on each of the second and third anniversaries of the award date. Under certain circumstances some or all of the vested shares may be settled in cash on a 1 for 1 basis based on the cash value of the underlying stock on the date of vesting.
- Balance includes 173 shares acquired on 03/10/2006 and 166 shares acquired on 06/10/2006 through the automatic dividend reinvestment feature of Exelon plans.
