Item 8.01. Other Events.

On February 27, 2009, Exelon Corporation (Exelon), Exelon Xchange Corporation (Xchange) and PECO Energy Company (PECO) submitted to the Pennsylvania Public Utility Commission (PAPUC) an Application for Certificates of Public Convenience Evidencing Approval of the Transfer of Ultimate Control (PA Application) of NRG Energy Center Pittsburgh LLC and NRG Energy Center Harrisburg LLC (Pennsylvania Energy Centers), each an indirect wholly-owned subsidiary of NRG Energy, Inc. (NRG), and, under an alternative potential corporate structure, of a possible change of control of PECO. The PAPUC regulates the Pennsylvania Energy Centers as utilities and must approve the change in control that would result from Exelon's acquisition of NRG. This filing relates to the offer (Offer) by Exelon through its direct wholly-owned subsidiary, Xchange, to exchange each issued and outstanding share of common stock (NRG shares) of NRG for 0.485 of a share of Exelon common stock. Exelon will also file a proxy statement on Schedule 14A and other relevant documents with the SEC in connection with its solicitation of proxies for a meeting of Exelon shareholders (Exelon Meeting) to be called in order to approve the issuance of shares of Exelon common stock pursuant to the Offer (Exelon Meeting Proxy Statement). **Investors and security holders are urged to read the NRG Meeting Proxy Statement and the Exelon Meeting Proxy Statement and other relevant materials as they become available, because they will contain important information.**
